**ELIGIBILITY**

Nominees must be for-profit, single-family builders or lot developers. They may be individuals or companies, employees or owners. Builders may nominate themselves or be nominated by other builders, charities, non-profit organizations, or government organizations they have helped. Special recognition will be given this year to employees of building firms, in addition to owners.

**THE AWARD**

A \$100,000 cash award will be donated to the winning builder's not-for-profit charity or community service organization. The winner and their charity will receive coverage in BUILDER magazine. A gala awards event will be held in the winner's honor during the 2010 International Builders' Show on Wednesday, January 20th, 2010.

**SELECTION**

A panel of industry judges will select the winner that has made the most significant contribution to public service over their lifetime. The judges' selection of the award winner will be final.
